Sub: Revised Scrutinizer's report on remote e-voting conducted pursuant to the provisions of Section 108 of the Companies Act 2013 ('the Act') read with Rule 20 of the Companies (Management and Administration) Rules 2014 as amended by Companies (Management and Administration) Amendment Rules, 2015 at the Annual General Meeting (AGM) of the Equity Shareholders of M/s. Franklin Leasing & Finance Limited held on Tuesday, 23rd September, 2025 at 01:00 P.M. through video Conferencing and Other Audio-Visual Means.

- 1. I, Akhil Agarwal, Company Secretary in Practice, having CP No. 16313 and Peer Review No. 4237/2023, has been appointed as the Scrutinizer by the Board of Directors of the Company vide resolution passed on 27th August, 2025, pursuant to Section 108 of the Companies Act, 2013 read with Rule 20 (ix) of the Companies (Management and Administration) Rules, 2014, as amended, for the purpose of scrutinizing the aforesaid voting process in a fair and transparent manner and ascertaining the requisite majority for passing of resolutions as contained in the notice convening the 33rd Annual General Meeting of the Company held on 23rd day of September, 2025.
- 2. The Management of the Company is responsible to ensure Compliance with the requirements of the Companies Act, 2013 and the Rules made there under relating to voting through electronic means (by remote e-voting) on the resolutions proposed in the Notice of 33rd Annual General Meeting of the members of the Company. My responsibility as Scrutinizer is to ensure that the voting process through electronic means at the meeting are conducted in a fair and transparent manner and render consolidated Scrutinizer's Report of the total votes casted in favour or in against if any, to the Chairman of the Company on the resolution, based on the reports generated from the electronic voting system provided by Central Depository Services Limited (CDSL).
- 3. The e-voting facility both for e-voting prior to the AGM (remote e-voting) and voting at the AGM by electronics means (e-voting) was provided by **Central Depository Services Limited (CDSL)**.
- 4. The remote e-voting period remained opened from 9:00 A.M. on Saturday, 20th September, 2025 to 5:00 P.M. on Monday, 22nd September, 2025.
- The Members of the Company as on "cutoff date", i.e., 16th September, 2025
 entitled to vote on the resolutions stated in the Notice of the Annual General Members of the Company.

- 6. The votes casted through e-voting and found not in accordance to the rules provided were treated as invalid.
- 7. As per the Information given by the Company, the names of the shareholders who had voted by remote e-voting through the facility provided by CDSL had been blocked and only those members who attended meeting through VC/OAVM and had not voted through remote e-voting, were allowed to cast their vote through evoting system during the AGM.
- 8. After the conclusion of voting at the AGM, the report on voting done through electronic voting system at the meeting was generated in my presence and the voting was diligently scrutinized.
- 9. Thereafter, votes casted through remote e-voting at the meeting were unblocked on 23rd September, 2025 in the presence of two witnesses, Ms.Prerana Gupta and Ms. Muskan Rathi, who are not in the employment of the Company. They have signed below in confirmation of the votes being unblocked in their presence.
